- If you do not have contact with your biological family, do you want to participate in the process of “Búsqueda de orígenes” (searching of origins)? (Servicio Nacional de Menores SENAME)

- In case of finding coincidences of your case with other complainant/victim, Would you like to participate on a process of “Búsqueda de orígenes” (searching of origins)?, this way you can be contacted by email by the pertinent entity.

It will be appreciated to accompany as many number of supporting documents as you can gather, such as copies of identification documents, birth and / or child-baring, copies of the judgment and travel authorization certificates, document of payment mate for fees for adoption, letters sent to the adoptive couple, etc. These documents must be sent in PDF format, as an attachment to the email **adopcionesirregulares@investigaciones.cl**, with a maximum of 20 megabytes. (You can send a second email incorporating another file making present that it is the continuation of a previous one)

It is important to point out that providing this information does not disqualify him/her from carrying out a parallel legal action, in particular a criminal complaint, as a plaintiff in the case, noting the existence of CAUSE ROL 1044-2018, followed by the Ilma. Court of Appeals of Santiago. To enter a CRIMINAL COMPLAINT, you must grant sponsorship to a lawyer, for which you can contact:
